The Capital Development Board provides professional consultation, design review, funding management and construction expertise to state building projects. CDB also is responsible for the renovation and rehabilitation of all state-owned properties, including removing hazardous materials, replacing leaking underground storage tanks, rehabilitating historic structures, and remodeling buildings to accommodate persons with disabilities. CDB is required by law to identify state construction projects that can use green principles. CDB also works with the State Board of Education to administer grants through the School Construction Program.

CDB's bipartisan board deliberates agency policy and direction and approves design professionals. The executive director is selected by the board to manage the agency and its employees.

The Illinois Commerce Commission contributes to the development of state and national policies on broadband deployment, renewable and energy efficiency standards, smart grid electricity transmission and delivery, technological changes on regulated utilities, and competition in the telecommunications, electric and gas industries.

ICC staff analyzes and evaluates rate proposals; conducts hearings; inspects rail, electricity and gas infrastructure; responds to consumer complaints; monitors interstate and intrastate motor carriers for safety, fitness and insurance; and promotes competition among utilities and electric, natural and telecommunication service providers.

The commission consists of five commissioners appointed by the Governor to five-year terms, with no more than three commissioners being from the same political party. The Governor designates a chair, and the commission employs an executive director who manages the agency's staff.

The State Board of Elections administers registration and election laws throughout the state. Duties include receiving nominating papers and certificates of nomination, and determining the validity of petitions and the order in which names appear on ballots. The board certifies to each county clerk the names of all candidates who have filed petitions to appear on ballots. Returns from both primary and general elections are filed with the board, and a canvass is conducted before results are certified.

The board also administers the Campaign Financing Act, which covers the public's right to know certain financial information about individuals and groups involved in political campaigns.

The Workers' Compensation Commission acts as the court for workers' compensation cases. Workers' compensation is a no-fault system of benefits paid by employers to workers who experience job-related injuries or illnesses.

The commission resolves disputes between injured workers and their employers regarding accidents, causal connection, extent of disabilities, medical expenses and other issues. Commission arbitrators conduct hearings at 32 sites throughout the state. Arbitration decisions may be appealed to a panel of three commissioners. Cases may then be appealed to the Circuit Court, Illinois Appellate Court and the Illinois Supreme Court.

The 10 members of the commission are appointed to four-year terms by the Governor, with the advice and consent of the Senate. No more than six members may belong to the same political party. The chair serves as the commission's chief executive officer.
