To ensure your application is processed, make sure that the amount of your remittance is correct according to the schedule of fees below. **Applications with incorrect fees will be returned.** Do not send currency or stamps; remittance must be in the form of a check, draft or money order made payable to Secretary of State.

A separate application must be used for ordering duplicates under each license number. It requires about four weeks to have additional plates manufactured.
